Treasurer's Report

We began the month of October with a balance forward of \$127,170. We brought in income of \$12,859. (Dues \$40, Gift Table \$277, Fundraiser \$12,542). Expenditures totaled \$19,060. (Administrative \$75, Communications/Media \$98, Community Engagement \$34, NFRW Convention \$750, Hospitality \$125, Dues to TFRW \$150, Literacy & Youth Outreach \$2,634, Ways & Means Fundraiser \$15,194. Our balance on hand as of October 31, 2023 was \$120,969.

The Metcalf Minute

An Update from the 87th Legislature at the Texas Capitol

I want to begin by thanking Texas voters for their support and approval of Proposition 4 during the constitutional amendment election. I was proud to author this legislation during the second called legislative session earlier this summer, and now voters have officially approved the largest tax cut in history, as well as much needed appraisal reform.

As you are well aware from our previous updates, the legislature has been engaged in multiple special sessions since the regular 88th Legislative Session which ended in May of this year. During this most recent 3rd called special legislative session in October, we passed Senate Bill 4 and Senate Bill 7 into law.

Senate Bill 4 will deter human smuggling and the operation of a stash house by increasing criminal penalties and establishing a 10-year mandatory minimum sentence for criminal conduct involving smuggling persons and the operation of a stash house. I was proud to co-sponsor this legislation. Senate Bill 7, which I co-sponsored, ensures Texans medical freedoms are protected by prohibiting employers from mandating their employees receive the covid vaccine as a condition of their employment. SB 7 will ensure no employee is unfairly discriminated against by an employer because of their covid vaccination status. Furthermore, this legislation ensures that no employer may take an adverse action against an employee because of their refusal to receive a covid vaccine. Under the legislation, employees can file a complaint with the Texas Workforce Commission if they believe they have been discriminated against and the employer may be penalized if it is found they have violated the law.

Governor Abbott has called the legislature back for the 4th called special legislative session which began on November 7th. Governor Abbott has tasked the Legislature with taking up legislation relating to education, specifically matters dealing with public school finance, teacher pay raises, school safety, and educational savings accounts. He also added legislation which would authorize Texas to take further action to protect our southern border by creating a state offense for illegal entry into Texas from a foreign nation, as well as legislation increasing funds to the state's border wall construction. As you know, only the Governor has the authority to call for a special session and determine what items are eligible for debate and passage. I take these issues extremely seriously and I look forward to continuing to fight for conservative legislation at your State Capitol.

It is an honor to continue serving the constituents of House District 16 in the Texas Legislature. Please know that my door is always open and I look forward to hearing from you. Do not ever hesitate to contact my office if I can be of service to you. May God bless you, your family and the Great State of Texas.



It's Political Season! Beware!

The 2024 Republican Primary elections are scheduled for March 5. Following are rules and laws of which we need to be aware.



Candidate filings began November 11, so it's important to know ahead of time the laws and rules concerning political signs. If you live in a subdivision or city, be sure to know the pertinent laws. For those under POA rules, the following state laws must be followed:

Sec. 259.002. REGULATION OF DISPLAY OF POLITICAL SIGNS BY PROPERTY OWNERS' ASSOCIATION. (a) In this section, "property owners' association" has the meaning assigned by Section 202.001, Property Code.

(b) Except as otherwise provided by this section, a property owners' association may not enforce or adopt a restrictive covenant that prohibits a property owner from displaying on the owner's property one or more signs advertising a candidate or measure for an election:

(1) on or after the 90th day before the date of the election to which the sign relates; or

(2) before the 10th day after that election date.

(c) This section does not prohibit the enforcement or adoption of a covenant that:

(1) requires a sign to be ground-mounted; or

(2) limits a property owner to displaying only one sign for each candidate or measure.

(d) This section does not prohibit the enforcement or adoption of a covenant that prohibits a sign that:

(1) contains roofing material, siding, paving materials, flora, one or more balloons or lights, or any other similar building, landscaping, or nonstandard decorative component;

(2) is attached in any way to plant material, a traffic control device, a light, a trailer, a vehicle, or any other existing structure or object;

(3) includes the painting of architectural surfaces;

(4) threatens the public health or safety;

(5) is larger than four feet by six feet;

(6) violates a law;

(7) contains language, graphics, or any display that would be offensive to the ordinary person; or

(8) is accompanied by music or other sounds or by streamers or is otherwise distracting to motorists.

(e) A property owners' association may remove a sign displayed in violation of a restrictive covenant permitted by this section.

Remember - no signs until 90 days before the election (December 5 if the primary is to be held March 5). Take them down before the end of 10 days after the election (March 16).

Texas Federation of Republican Women Rules on Endorsing Candidates

"Please remember all rules apply in endorsing or supporting: Club Presidents and Campaign Activities Chairs cannot endorse, nor can the club endorse. No member should use their club's name when endorsing and all Federal guidelines apply for Congressional candidates". **Note:** NSRW members (except president and campaign activities chairman) can endorse as individuals, and are urged to get involved in Republican candidate campaigns, but not in the name of NSRW. Wearing your NSRW nametag or shirt to a campaign event for a candidate may be construed to be an endorsement, so it's not a good idea to wear those to fundraisers, meet & greets, and other events for candidates. We will, of course, wear our NSRW shirts to our January 30 candidate forum.
